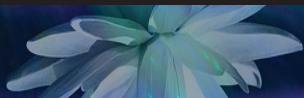

## OVERCROWDING IN A LINE UP AND WHAT YOU CAN DO ABOUT IT

Handlers can become quite frustrated when confronted by competitors who overcrowd their dogs in a stacked line up. By overcrowding, I refer to situations where the competitor behind one dog stacks their dog in very close proximity to the dog in front.

In many situations, overcrowding can occur quite innocently. In other situations, it can show a lack of respect or knowledge about ring etiquette. In some situations, it can even be applied as a deliberate tactic to intimidate other exhibitors and even to confuse or pressure a judge when making their final decision.

Whatever the cause of overcrowd-

ing may be in a particular situation, in this blog I'd like to outline some ideas for how you can manage overcrowding in the show ring, including tips about how to:

- apply techniques to gain your rightful space
- reduce your frustration
- avoid unnecessary confrontations with other exhibitors.

1. When you're first to enter the ring.

When you're first in the ring and the competitor behind you stacks their dog too close to yours, don't panic. Simply start stacking your dog, which, if you follow my

technique should only take a few seconds. You can then wait for the competitor behind you to start stacking their dog.

If they start to do this too close behind you, simply move forward so there's about a three-foot (90 centimetre) distance between you and the next dog, and then re-stack

impatient eye of the waiting judge (who, in my experience, dislike overcrowding nearly as much as handlers do).

2. When you're in the middle of a class.

If you have a dog in front of you and another dog close behind, good



your dog.

If your stacking skills are up to scratch, then you should be able to complete a second stack before your competitor has even finished their first. However, if you should find (with human nature being what it is sometimes) that the competitor behind you gives up stacking their dog and moves closer to you and starts stacking their dog again, simply stand your ground and trust that this won't go unnoticed by the

stacking skills can also help you prevent overcrowding and empower you to manage the vagaries of a stacked line-up to your advantage.

For example, when the dog in front of you stops, use a calming sound to indicate to your dog that they should watch you as you slow down and come to a halt about six feet (two meters) away from the dog in front. As I will explain next, doing this will help you prevent overcrowding from any dog coming

up behind.

By allowing extra space before you come to a stop from the dog in front of you, you can stay cool and wait for the exhibitor behind you to stop and start stacking their dog. Once they start to do this, you can move your dog up to three feet (90 centimetres) away from the dog in front of you and complete your stack all the while guaranteeing a good space behind you and the next dog in the line-up.

By doing this, less experienced or more aggressive competitors will be less likely to sacrifice the time that they've already put into their stack to move forward and overcrowd you.

### 3. Don't make a fuss.

Whatever the situation or cause that leads to the overcrowding of your dog may be, I strongly recommend against arguing with the handler responsible for doing it while you're in the ring.

Not only can asking the overcrowding handler to 'stop' what they're doing be fraught with physical danger (and yes, it's been known to happen), it's also unnecessary if you use the handling techniques that I've set out above.

It's also an unsightly display of poor sportsmanship, which may not only attract negative attention from

the judge, but may also attract unwanted commentary from ringside spectators who may or may not have a full understanding of the situation.

The fact is, some overcrowding is intentionally designed to pressure competitors and judges, while some overcrowding is the unintentional result of sharing a show ring with less experience competitors.

Either way, my show ring philosophy is about controlling what you can and not worrying about what you can't. The minutes you might spend worrying about why you've been overcrowded could be better spent in a few seconds addressing the problem at hand, i.e. demonstrating to the judge why your dog is more worthy of a particular award than any other dog that's also on show.

Finally, as a last resort, should the above techniques not work to your advantage and you're still being routinely overcrowded by a particular competitor; notify the ring Steward and ask for their assistance in keeping an eye on the perpetrator in a loud enough voice so that the offending handler hears you.

Believe it or not, if the overcrowding is deliberate, then you'll never have the problem occur again.

## Apple Cinnamon DIY Dog Donut Cookies

### DONUT INGREDIENTS

- 1 medium or large apple (washed, peeled and grated)
- 3 cups whole wheat flour
- 1 tsp ground cinnamon
- 1½ cups oat flour
- 1 cup water
- 1 egg
- 2 heaping tbsp coconut oil

### ICING INGREDIENTS

- Plain Greek yogurt
- Honey

### DIRECTIONS FOR DONUTS

1. Preheat oven to 350°F.
2. Line 2 baking sheets with parchment paper.
3. Add whole wheat flour, oat flour, and cinnamon to a large bowl and whisk together.
4. In a smaller bowl beat egg, then add water, grated apple and coconut oil. Mix together.
5. Add the wet ingredients to the dry ingredients and mix together well.
6. Knead dough ball with your hands for 3-5 minutes, until it is thoroughly combined.
7. Roll dough ball flat to about ¼

- inch thick and then cut out donut shapes. I used a round cookie cutter and for the donut hole I used a small bottle cap. Be creative!
8. Place donuts and holes on baking sheets.
9. Bake for 25 - 30 minutes in 350°F oven.

### DIRECTIONS FOR ICING

1. Mix plain Greek yogurt with some honey to create icing.
2. Glaze donuts and freeze for 30 minutes to harden glaze.
3. If you are adding icing, store treats in refrigerator for up to 5 days. Freeze after 5 days.

### Notes

\*For softer donut remove from oven to let cool.

\*For harder donut let cool in oven.

\*Remember these are fresh baked and do not have preservatives so follow storage instructions.  
\*STORAGE: Unfrosted - In airtight container in refrigerator for 1 week.

Then in freezer for up to 3 months. Take out portions as you need them.



## Tuna Brownies

*Submitted by Leslie Jean Gray*

- Preheat oven to 350F
- Drain 2 regular (5-6 oz) or one large can of tuna and pour into mixing bowl.
- Mix in 2 eggs-include the crushed shells if you want more calcium.
- Mix in 1 1/2 cup flour (I use garbanzo bean flour, you can use whole wheat, oat or rice flour)
- Add 1 T garlic powder or crushed garlic.
- Blend well, form into doughy ball. Spread about 1/4 inch thick on big greased cookie sheet.
- Bake about 25-30 minutes or until golden. Cut into tiny squares before they get too cool. You can also sprinkle extra garlic on top before putting them in the oven.
- Store in airtight container or freeze.

## Instant Egg Custard

For puppies: Beat one egg; add four tablespoons of milk (goat's milk, if possible); put mixture in a metal cup over hot water, boiling for three to four minutes until eggs set. A dash of honey may be added for energy. Serve with love!

A recipe I found to be of help for brood bitches with large litters that you may want to try is as follows: one package of vanilla pudding; four cups goat milk or half-and-

half; half a cup of honey; and four eggs. Mix and cook over medium heat stirring constantly until mixture comes to a boil. Feed at room temperature twice a day. This will keep three or four days in the refrigerator. This recipe is also good for young pups.

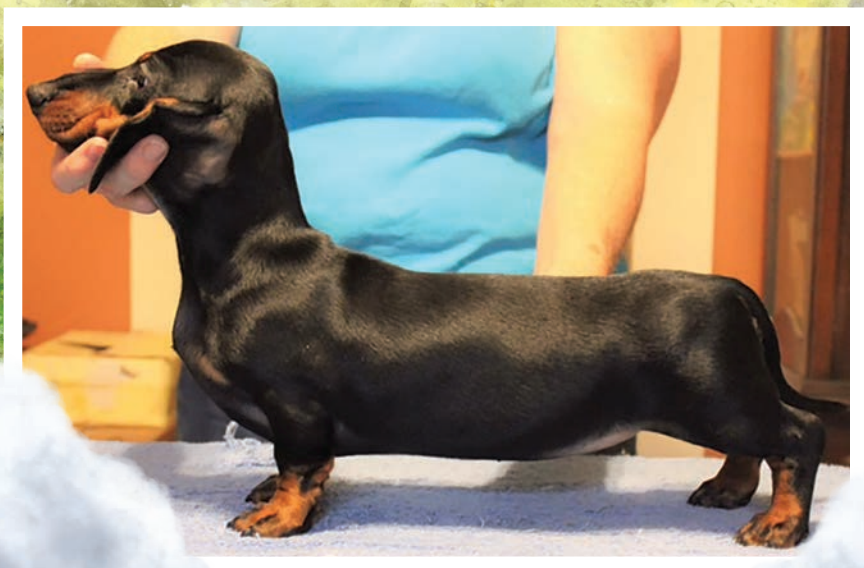

## ATTENTION DACHSHUND AND HOUND JUDGES!



The following revision to the AKC Dachshund Breed Standard was approved November 14, 2017 and effective as of January 1, 2018

"Piebald is a pattern (as opposed to a color) with clearly defined areas and/or patches of white on any allowed one-colored or two-colored dogs. Two-colored piebald patterned dogs may show tan markings on the face and around the anus. There are no patches of lighter shadings within the colored areas as in the dapple pattern. Ticking in the white areas is acceptable. Eye color, eye rims, nose and lips are well pigmented and in accordance with the base color; eyes are never partially or wholly blue as distinguished from the dapple pattern. Eyes

partially or wholly blue is a disqualification. Head must not be more than 50% white and color(s) other than white must cover both ears, back and front, and extend without interruption from the ears over both eyes. A head of more than 50% white or white on any portion of either ear, back or front, or around the eyes is a disqualification. Pure white dogs with no body spots except on the head are to be disqualified. Nails may be partially or wholly white.

Disqualifications in the piebald pattern: eyes partially or wholly blue, or a head of more than 50% white, or white covering any portion of the ears, back and front, or around the eyes, or pure white with no body spots except on the head.

## **NMDC Board Meeting Minutes, April 29, 2018**

The Board of the National Miniature Dachshund Club met on April 29, 2018 at the Worthington Doubletree Hotel in Worthington, Ohio. Those in attendance were: Aubrey Nash, Emmajeane Stephenson, Laura Abbott-Licht, Janelle McCord, Sandy Combs, David Temple, Tara Hartman, Janice Corey-Finney, Pat Hodges, and Kim Ragsdale.

President Aubrey Nash opened the meeting at 12:30 pm. The minutes of the last meeting on September 14, 2017 were reviewed and corrected. Sandy Combs will incorporate the changes and send them to the Digest editor for publication.

Later in the meeting, Sandy Combs gave the treasurer's report. The current balance is \$41,036.48. David Temple has agreed to assume the treasurer's duties when Sandy retires from the position. Sandy listed the duties she performs and suggested that the treasurer continue to be bonded. We will be looking for a new webmaster as well.

Laura Licht reported that she has asked 3 members to join her in reviewing the breed standard. The committee consists of Carol Burton (longs), Marie Dorris (wires) and Cliff Ramos (smooths).

Janice Corey-Finney, membership chair, read the application of Aaron and Allison Stutzman. Janelle McCord moved to accept the application, seconded by David Tem-

ple; it was approved unanimously.

Pat Hodges gave a report on the 2018 NMDC National Specialty to be held in Knoxville, TN on November 2. The premium list is to be mailed Sept. 5 and the catalog deadline will be Oct. 5. MB-F is the superintendent. The closing date will be the same as for the host all-breed shows.

Responsible parties are: Pat Hodges, show chair; Janelle McCord, corresponding secretary; trophy donations, Tara Hartman; trophies, Kim Ragsdale; ribbons, Janelle McCord; ways and means, Laura Licht; raffle, Laura Licht, Karen Osborne and Beth Reinhart; ticket and shirt sales, Emmajeane Stephenson; dinner reservations, Sandy Combs. Pat Hodges will get the judge's contract from Sandy and send a letter to Jan Swayze-Curry. She will also invite Glenn Lykin, the Director of Event Operations for AKC, who approved our show.

Laura and Pat gave a report on banquet facilities. An alternative to the original site was explored by Laura because the room was too small for the raffle. However, the new proposed site is 22 miles from LaQuinta, the host hotel and some members felt this would negatively impact attendance. The group decided to use the original location, 10 miles from the hotel, and set up the raffle at the show. The raffle committee will reserve some items to be auctioned at the dinner.

Laura stated that the VP position

is the only office lacking a description of duties in the By-laws and suggested that 3 VP's are not needed. Eliminating a position would require a By-laws change. There was no motion to this effect.

Aubrey's comment that one VP should be show chair led to a discussion of show chairs. Emmajeane stated that the show chair/coordinator must be local. David stated that clubs wishing to host the National Specialty must submit a proposal and identify a show committee.

Purina Farms is an issue. Kim suggested dividing duties among the board. It was noted that most clusters are becoming 4 days, which can be too long to add our show. Kim suggested that we consider evening shows for the future, but Emmajeane commented that the superintendents often charge extra for evening equipment rental.

The group reviewed the Code of Ethics in response to the written concerns of a member. It was noted that there are no required health screens for dachshunds at this time, although the Board supports voluntary screening. The airlines control the minimum age for shipping. The Code on the web site permits the use of dogs registered by the primary agency in other countries. Janelle moved that the statements concerning the use of non-AKC or unregistered bitches and not selling puppies before 8

weeks of age should remain, with the elimination of the minimum 12 weeks for shipping requirements and the health screening statement. Janice seconded and the motion passed unanimously. Sandy will reconcile the hard copy and the web version.

Janelle reported on the status of the MidStates Miniature Dachshund Club. A meeting of those listed as members at the last meeting were invited to a meeting in February in Indianapolis and voted to re-activate the club. A slate of candidates was presented and votes were counted by Tina Worthington. The newly elected officers will discuss how to proceed with a possible Mid-States "top 15" show in TN and an application will be submitted if needed.

Leslie Gray, Facebook page administrator for the NMDC page, would like to see more use of the page. Janice stated that she had recently posted about the available ad space in the May Digest. Kim suggested that the page be opened to be public in order to attract members, etc. There would need to be rules about no dogs for sale, no brags. Janice and Kim volunteered to become administrators with Leslie.

Laura commented on problems with the Yahoo Board group and suggested that the Board use a Facebook messenger group to improve communication. Janice

volunteered to set up the group.

David Temple reported that the nominating committee has been working to propose a slate by July 31. Emmajeau moved to appoint Janelle McCord interim secretary to complete the term of Phil Benway, who recently resigned for personal reasons. Kim seconded and the motion passed unanimously. Dianne Graham will be asked to fill the newly vacated 3rd VP position until January 1, 2019.

The Board will recommend to the membership that the 2019 National Specialty be held in Springfield, Missouri, the 2nd weekend in November with the Ozark Mt. Fall Classic. NMDC will be provided a large room for rings and grooming and allowed to offer the show as a concurrent specialty. The superintendent is Onofrio and the contact is Linda Williams. Aubrey will coordinate. The Best Western has good facilities, approximately \$75 per night, no pet fee.

Janice will seek more information on a possible show near Galveston, TX for 2020. Kim will explore possible future show with Morgantown, WV.

Laura discussed involvement with DCA. A donation from NMDC for hospitality was noted. She suggested aligning a board meeting with DCA week when possible.

Janice requested permission to purchase a conference phone

for board meetings at an approximate cost of \$267. Kim moved to approve, Pat seconded and the motion passed. Janice will purchase the phone and submit the receipt to Sandy.

In other business, Pat noted silver dollars for purchase that highlight the year of the dog. These could be donated by members. Kim will review the trophy list for TN Valley. NMDC will offer medallions for first in open miniature classes.

Leslie Gray submitted a report that indicates she has nearly completed the task of scanning the post 1970 Digests and 5 stud books. Her goal is to complete this by the National Specialty and make available for purchase on flash drives. She is in need of the October 1970, October 79, August 74 and December 85 Digests.

The need to stimulate advertising in the Digest was discussed. Each issue is sent to Hound Group judges and the ads are comparatively inexpensive. Janice suggested designating a focus for each issue, such as studs past and present, futurity, bitches, etc. She will post reminders on the club Facebook page.

The meeting was adjourned at 4:14 pm. The next meeting will be scheduled in conjunction with the National Specialty in TN in November.
